GENERAL DESCRIPTION OF TASK (S) AND OBJECTIVES TO BE ACHIEVED

Under the general supervision of Coordinator, Marine and Inland Fisheries Service (FIRF), the technical supervision of the Chief, Development Law Service (LEGN), the guidance and direct supervision of the Regional Project Coordinator of the Protection of the Canary Current Large Marine Ecosystem (CCLME) and in close cooperation with relevant staff and counterparts of the project, the consultant will in particular carry out the following tasks:

- Prepare an orientation paper on a governance framework for the CCLME, comprising: an overview of the current legal and institutional framework; a description of how the different elements of the framework are interrelated; an analysis of gaps, inconsistencies, overlaps of the legal and institutional framework and; recommendations for improvements building on strengths and opportunities present. The orientation paper will also take into account the governance of existing institutions in the sub-region, such as SRFC, COMHAFAT and the Abidjan Convention;
- Present the orientation paper at project workshop and facilitate discussions related to governance framework issues;
- Assist with the assessment of governance related issues affecting the CCLME as part of the TDA;
- Prepare a final report with recommendations for strengthening the legal/institutional framework, building on the assessment carried out, to be integrated in the SAP.
