GENERAL DESCRIPTION OF TASK(S) AND OBJECTIVES TO BE ACHIEVED

Under the general supervision of the Chief, Marine and Inland Fisheries Service (FIRF), the guidance and direct supervision of the Regional Project Coordinator, and in close cooperation with relevant staff and counterparts of the project, including from the FAO Products, Trade and Marketing Branch (FIPM), the consultant will carry out a study aiming at identifying priority transboundary concerns with regard to fish and fishery product trade and recommendations to strengthening policies to address them as part of the Strategic Action Plan (SAP). More specifically the consultant is expected to:

- Based on the draft ToC attached in annex, prepare an annotated outline of the study for review by the CCLME project WG on socio-economics and trade.
- Develop ToR/ToC for national reports that will feed into the regional report.
- Coordinate the work of the national consultants.
- In collaboration with the WG and other partners, identify priority actions to support regional trade policies and market mechanisms to support sustainable fisheries and aquaculture while encouraging regional and international trade in fish and fishery products with no detriment to the countries' rights and obligations under the WTO agreements.
- Identify in a participatory manner appropriate regional trade policies and market mechanisms to support sustainable fisheries while encouraging regional and international trade in fish and fishery products with no detriment to the countries' rights and obligations under the WTO agreements.
- Prepare a first draft policy paper for CCLME countries and present the paper at suitable meetings within the Transboundary Diagnostic Analysis (TDA)/Strategic Action Plan (SAP) process.
- Based on feedback received prepare a refined policy paper for integration into the SAP and present the policy paper at meetings related to the SAP working group.

Draft Term of Contents

Objective:

The aim of this paper is to analyze trade in fish and fishery products (from capture fisheries and aquaculture) of the CCLME region in recognition of the key role trade plays in economic development and food security at the national and regional levels and the increasing influence of market forces on the management of fisheries and aquaculture (and vice versa). After an overview of recent trends in fishery production in the CCLME region (capture fisheries and aquaculture), the study will focus on the exchange of fishery products within the region and with other regions. The analysis will consider both the quantitative and qualitative aspects of trade, including trends and projections in production, consumption and trade as well as the legal and policy frameworks covering both the production and trade sides of the fisheries sector. This analysis of fisheries and aquaculture production and trade should identify constraints and opportunities and provide conclusions and recommendations for the future development of fisheries and aquaculture product trade in the CCLME region in support of the Millennium Development Goals. The paper will provide inputs into the CCLME Transboundary Diagnostic Analysis (TDA)/Strategic Action Plan (SAP) process.

- 5. Discussion regarding trade and its contributions to the Millennium Development Goals in the CCLME countries
- 6. Analysis of barriers and opportunities for CCLME countries (including available market projections and discussion on potential trade-offs/benefits for national food security and economic growth tied to trade)
